As matters stand in late 2020, the following topics will be addressed:

- **UIF:** The TERS benefit is likely to be followed by the Reduced Work Time benefit – what is it?
- **PAYE and PIT:** Far-reaching administration reforms for the future
- **Home Office Expenses:** Areas of concern

Besides wrapping up the ETI, tax, and TERS benefit relief measures, also included are items from the newly promulgated Amendment Acts, including:

- **Provident Fund Payouts:** Important changes, and protection of vested interests
- **February 2021 Tax Certificates:** Rejection of tax certificates by the SARS Employment Tax Validation process
- **Employment Tax Incentive:** Rollover anomaly to be fixed, and other matters of interest
- **Bursaries:** Reclassifying remuneration as exempt bursaries
- **Foreign Employment Remuneration:** The late change, and the payroll administration complications
